

Gaston Medical Associates, located in the Community Health Partners (CHP) network, has been both a CCPN and a Practice Transformation Network (PTN) participant since March 2016.

Quality Focus:

The practice had a key interest in Behavioral Health Integration, and this was reinforced after the CHP PTN Coach, Megan Wilson, conducted their baseline PTN practice assessment.

After an initial collaborative meeting that included the practice physician, Dr. Fola Ajao, work began moving forward. Erin Greene, BHI Specialist at Community Care of Southern Piedmont (CCSP) has been working with Gaston Medical Associates for the past several months on BHI in collaboration with Dr. Karen Melendez (Network Psychiatrist for CCSP, CCPGM, CHP), Anne Wheeler (BH Coordinator at CHP) and Megan Wilson (CHP PTN coach).

Gaston Medical Associates is interested in implementing the Collaborative Care Model of integrated care, in an effort to better manage patients with depression. Over the last couple of months they have successfully begun implementing important pieces of the model, including depression care management, and recently started billing the new Medicare G codes for integrated care. Great work and collaboration is taking place in this practice.

Burlington Physician Wins Doctor-of-the-Year Honor

This spring, CCPN physician Karin R. Minter, MD, MPH, FAAP, was named

2017 NC Doctor of the Year by the North Carolina Medical Society.

Dr. Minter is a pediatrician with Burlington Pediatrics in Burlington, where she has practiced medicine since 2006.

The Doctor of the Year selection process started in February when patients, colleagues, family and friends nominated doctors from across the state who they felt exemplified the best qualities of caring, compassion, clinical expertise and community involvement. Doctors were nominated through the NC Doctors' Day website.

In mid-March, 10 finalists were selected by peers from among the nominees.

Dr. Minter was the top votegetter among the 22,588 online votes cast.

The award came with a \$5,000 prize to further a professional or community project of the winner's choosing. Dr. Minter donated her award to two

charities: Alamance County Partnership for Children and Reach Out and Read of Alamance County.
