

Board of Managers Approves Quality Metrics

In March the CCPN Quality Assurance and Improvement Committee, via its Pediatric and Adult sub-committees, submitted to the Board of Managers proposed quality metrics to be measured and reported to payers. The Board of Managers adopted these recommendations and work is now under way to begin collecting data on these metrics.

The approved metrics are:

Pediatric metrics

Well-Child Visits in the First 15
 Months of Life

- Well-Child Visits in the Third, Fourth, Fifth and Sixth Years of Life
- ♦ Adolescent Well-Care Visit
- Childhood Immunization Rate
- ♦ Adolescent Immunization Rate, and
- Human papilloma Virus (HPV) Vaccine for Female Patients

Adult metrics

- ♦ Breast Cancer Screening Rate
- Colorectal Screening Rate
- ♦ Controlling High Blood Pressure, and
- ♦ Diabetes A1c Control

Purchasing Expert Addresses Board of Managers

The CCPN Board of Managers met in Greensboro on March 30. The meeting was kicked off by a presentation by Beth Waldman, JD, MPH, Senior Consultant with Bailit Health Purchasing, a nationally recognized firm that has consulted with many states and organizations on value based purchasing. Ms. Waldman gave a brief overview of key concepts including Advanced Alternative Payment Models (APMs), the Quality Payment Program (QPP), and the Merit-Based Incentive Payment System (MIPS) before participating in a healthy and informative discussion with the BOMs on various payment reform strategies. Ms. Waldman provided the BOM with a robust slide deck that included information on Accountable Care Organizations (ACOs), Primary Care Capitation, and Episode Based Payments and what variables to consider when determining what payment methods will work in a specific practice.
