

2017 achievements pave the way for a strong 2018 for CCPN

As 2017 draws to an end, I am excited by what CCPN has accomplished over the last year and looking forward to what we can do in 2018.



from just over 1,300 clinicians and 383 practices to over 2,100 clinicians and more than 650 practices.

CCPN has expanded to include OB/GYN and Behavioral Health providers. We held a very successful Inaugural Clinicians' Conference in Greensboro in May, added a Direct Primary Care plan, and joined a group vaccine purchasing agreement to better serve our clinicians.

In January we will begin our Medicare Advantage pilot in nine practices. In addition, we have signed two letters of intent with Medicaid MCOs (Managed Care Organizations).

In 2018 we will continue to add practice support and plan offerings for our clinicians and to work on the quality outcomes that will drive our success in the future.

Let me take this opportunity to thank you for all of your work on behalf of CCPN this year. Because of you CCPN is ready to tackle the opportunities that lie ahead in 2018.

The CCPN Board of Managers (BOM) met on November 6 and discussed a wide variety of topics.

Interest in the CCPN model for engaging independent physicians in quality driven care is continuing to grow nationally, with several states reaching out to learn more about what CCPN offers. In addition the Board discussed how to continue to position CCPN to best meet the needs of its physicians while looking at new opportunities to grow.

The Board also unanimously accepted AccessEast's nomination of Dr. Beverly Edwards as a Manager to the CCPN Board. Dr. Edwards is an independent pediatrician from Ahoskie. The BOM will meet next in Greensboro on December 7.

Rural Primary Care Practice Results Prove Investing In Quality Pays

Randy Barrington, MBA, Quality Improvement Director for CCNC of the Lower Cape Fear, presented a poster at the national NCQA PCMH in Orlando



held November 3-5, 2017 (https://www.pcmhcongress.com/) on the Return on Investment for the NCQA PCMH Recognition in Independent, Rural Primary Care practices.

PCMH RETURN ON NVESTMENT

The poster shown above highlights some challenges independent, rural primary care practices find in creating and following a framework outside of NCQA PCMH that provides them the same benefits and positive outcomes that PCMH brings.

Within the CCNC of the Lower Cape Fear network, many of the practices' innovations and preparedness for value-based care have come directly or indirectly from the work the practices have done to achieve PCMH recognition.

The Return on Investment calculations have taken into account the time, energy, equipment, software and other tools practices have utilized to realize direct and indirect financial benefits and positive outcomes.

One key finding is that when a team-based structure is in place that allows for everyone to work at the top of their license, staff turnover and costs associated with staff turnover decrease.
