Board of Managers Spotlight: Dr. Beverly Edwards



I was born and raised in Raleigh. My parents, Joseph and Emma Edwards, encouraged scholastic and cultural advancement. And with some diversions, I fulfilled my dream of attending medical school at the Brody School of Medicine in 1988. I did my residency in Pediatrics at Medical College of Virginia in Richmond finishing in 1991. I have been in practice in Ahoskie as owner and lead physician at Ahoskie Pediatrics ever since.

Based on personal experience when I applied for Medicaid for myself and my nine year old son as a medi-

cal student (and was denied because I left a full-time job to go to medical school) I learned not to judge who needs what or who pays for someone's medical care. It also became my personal goal to see all people covered with medical insurance without prejudice.

I am proud to serve our Medicaid and private pay mix of patients. In the present climate of change I believe the biggest challenges will be in how patients are medically covered insurance-wise and how physicians will be paid. My practice has faced financial hardships in the past and came close to closing. I found my footing after receiving support from various sources including the NC Pediatric Council (Drs. Graham Barden and Christoph Diasio), the NC Pediatric Society, Community Care of North Carolina, AccessEast and CCPN.

The people of Ahoskie have made me feel very welcome over the last 27 years. In return I want to be the best advocate I can be for the children and families I serve in our our four county area (Hertford, Bertie, Northampton and Gates) in rural eastern NC. My goal is to learn how to navigate this new medical/financial pathway with the people who have been the leaders of this effort. I hope that our four county rural area will flourish in terms of providing quality medical care in a patient centered medical home. I want to see NC back at the top again in terms of how we take care of each other.

Aetna Agreement

Announced

On January 10, 2018, Aetna and Community Care of North Carolina. Inc. (CCNC) announced a new agreement to combine Aetna's expertise in Medicaid managed health care services with CCNC's medical home and care management services, Community Care Physician Network, LLC (CCPN), and Community Pharmacy Enhanced Services Network (CPESN) USA (Link to announcement).

In this value-based agreement, CCNC will perform care management and coordination services and CCPN member physicians will be "in-network" for Aetna's Medicaid members and eligible to treat all these patients.

So that your current and future patients can stay connected to your practice, it's important that the information in Aetna's network directory is complete and accurate. To make sure this is the case, an Aetna representative will be contacting your practice to collect your contact information.

CCPN Launches First Medicare Advantage Pilot

CCPN's first Medicare Advantage program began in January with the nine pilot practices that will participate in the first year.

These practices are Clinton Medical Clinic, Moore Family Medicine, Lillington Family Medical Center, Stat Care Urgent and Primary Care, Fayetteville Internal Medicine, Cumberland Internal Medicine, Village Family Care Center, Southern Regional AHEC, and Naveed Aziz, MD.

These practices will be working to positively impact the quality of care that their patients receive as measured by the Aetna Medicare Advantage quality metrics.

Additional value-based payments to the practices are available based on how the practices perform on these metrics.

After learning more about what works and getting the quality reporting infra-

structure in place, CCPN plans to expand the number of pilot practices participating in this program in year two. Look for additional updates coming soon.
